The adviser seeks to identify high quality businesses by focusing on companies with the following attributes: attractive business fundamentals; experienced, motivated company management; pricing power; sustainable competitive advantages; financial strength; and high or consistently improving market position, and return on invested capital. The adviser then considers whether the company's stock is trading at an attractive price relative to what it believes to be fair value.
